Further, I release Bear Creek Stables, Inc., its officers, employees, or agents from any liability, loss, damage, cost, expense, or cost whatsoever on account of first aid or medical treatment or service rendered either to me or to my CHILD as a result of participation by me in any activity at Bear Creek Stables, Inc.

In consideration of the services provided by Bear Creek Stables, Inc., I agree to maintain health and accident insurance on CHILD. I assume full financial responsibility for any and all accidents, harm, or injuries CHILD incurs while participating in any activity at Bear Creek Stables, Inc.

In furtherance of my obligations under this agreement, I agree to defend Bear Creek Stables, Inc., its officers, agents, employees, other customers, the owner of any horse ridden at the direction of Bear Creek Stables, Inc., its officers, employees, or agents, successors, and each of them against all suits, claims, demands, and actions by and through legal counsel chosen by Bear Creek Stables, Inc.
